

ORDERS OF LIFE ASSOCIATION RELEASE OF LIABILITY

Please read this release and initial each provision to indicate that you have fully read it and that you fully understand it. Then sign and date this form and mail with your training application.

In consideration of Orders of Life Association (OLA) allowing me to attend and participate in the Training Program, I, _____, on behalf of myself, my heirs, executors, administrators and assigns, hereby agree:

_____ 1. I understand that in the course of the six (6) training seminars, I will have the opportunity to work with my own personal issues and challenges and that my personal constellation healing work is designed to assist me to avoid future blind spots and the triggering of resistance in future clients.

_____ 2. I understand that Orders of Life Association's Soul Healing Work (OLS) and the methodology of Systemic Constellation Work (SCW) is an experiential healing process, based on humanistic and spiritual principles that may or may not assist in personal growth and healing. OLS/SCW is not intended to be psychotherapy or medical treatment or a substitute for either one. I understand that OLS/SCW involves sharing and that I will experience deep emotions, which may include emotional stress, anxiety, tears, physical discomfort or exhaustion.

_____ 3. **ASSUMPTION OF RISK:** I am fully aware that participating in OLS/SCW may contain risks of physical, emotional and psychological injury. I declare that I have the mental health, emotional stability and physical ability to handle OLS/SCW. I voluntarily and freely choose to incur and assume any and all such risks.

_____ 4. **EXEMPTION FROM LIABILITY:** I hereby fully and forever discharge and release Orders of Life Association, Heinz Stark, Margot Ridler, Healing Heart and Soul, and their respective partners, officers, subcontractors, consultants, agents and representatives from any and all liability, claims, losses, demands, actions and causes of action whatsoever, both in law and equity, arising out of or in any way resulting from personal, physical, psychological or emotional injuries, distress or death, allegedly sustained during or from OLS/SCW or any of its associated activities.

_____ 5. **COVENANT NOT TO SUE:** I agree not to institute, initiate or assist the prosecution of any suit, claim or action at law or equity, or otherwise against Orders of Life Association, Heinz Stark, Margot Ridler, Healing Heart and Soul, and their respective partners, officers, subcontractors, consultants, agents and representatives or training participants for damages, injury or losses for which I or my heirs, executors, administrators or assigns hereafter may have arising from OLS/SCW or any of its associated activities.

_____ 6. **INDEMNITY AGREEMENT:** I agree to indemnify, defend and hold harmless Orders of Life Association, Heinz Stark, Margot Ridler, Healing Heart and Soul, and their respective partners, officers, subcontractors, consultants, agents and representatives from any claims, actions, damages, liability, losses and expenses (including attorney fees) arising directly or indirectly from my participation in the Orders of Life Association Training Program or any OLS/SCW work.

_____ 7. **WAIVER OF PUNITIVE DAMAGES:** I hereby waive and forever abandon any claim for punitive or exemplary damages against Orders of Life Association, Heinz Stark, Margot Ridler, Healing Heart and Soul, and their respective partners, officers, subcontractors, consultants, agents and representatives or training participants in connection with or arising out of my participation in OLS/SCW. I voluntarily choose to give up this right.
