WITNESSETH: That in consideration of the mutual covenants and agreements to be kept and performed on the part of said parties hereto, respectively as herein stated, the parties agree as follows:

A. Trainee agrees to:

- _____ 1. Pay the fees and deposits set forth on page 5 of the training packet.
- _____ 2. Certify that Trainee meets the Training Application Requirements on page 6 of the training packet.
- _____ 3. Abide by the standards and policies set forth in the Training Commitment and Certification section on page 7 of the training packet.
- _____ 4. Accept the Training Cancellation Policy on page 7 of the training packet.

This agreement shall be binding upon the parties, their successors, assigns, heirs, and personal representatives. Time is of the essence on all undertakings. The complete contents of this training package including but not limited to the Registration Form, Member Agreement, and the Release of Liability shall constitute the whole of the training contract agreement from pages 1 through 19 wherein all parties' signatures are hereby evidenced.

B. Trainer agrees to:

Trainer shall not be considered in default of this Agreement for delays in performance caused by circumstances beyond the reasonable control of Trainer including, but not limited to, abnormal weather conditions; floods; earthquakes; fire; epidemics; war, terrorism, riots, and other civil disturbances; strikes; lockouts; work slowdowns, and other labor disturbances; sabotage; judicial restraint; and inability to procure permits, licenses, or approvals from any local, state, or federal agency for any of the supplies, materials, or services required to be provided by Trainer under this Agreement.

Healing Heart and Soul is acting solely as the sponsor of the Orders of Life Association Training Program but shall not be responsible for performance of the training program and Healing Heart and Soul makes no representations and warranties that the training program will result in personal growth, professional success or any accomplishment of any kind whatsoever.

This agreement contains all the term and conditions agreed upon by the parties hereto and no agreement, once or otherwise regarding the subject matter of this agreement shall be deemed to exist or be binding upon any of the parties here.

The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering a portion of provision of this Agreement void shall in no way effect the validity or enforceability of any other portion of this Agreement.
